Burton (Harisyanto, 2011) identifies a student can be suspected of experiencing difficulties learning if the horse shows a failure in achieving the goals of learning. Difficulty learning of students indicated the presence of obstacles to achieve the result of learning that is good, a good that is psychological, sociological, and physiological, so that in the end can lead to the achievement of learning that is achieved is below that should.

Based on the phenomena found in MAPN 4 Medan which will be the place of research and based on the results of the preliminary studies conducted when the researchers conducted the Field Experience Counseling Practice in class XI, there were several obstacles in learning activities so that their development was not optimal. These obstacles can be seen from the behavior of students who show laziness to learn, feel afraid in facing tests or exams, are slow to understand the material provided by the teacher in class, are slow to complete assignments given by the teacher, feel unable to understand some subjects, and lack of enthusiasm in learning.

The phenomenon described above is based on the results of AUM PTSDL that has been given by researchers in class XI, especially XI IPA-5 with a total of 35 students, then interviews with counseling teachers and homeroom teachers of class XI IPA-5. From the results of the AUM PTSDL processing they had filled, with a total of 35 students, 10 people were identified as having difficulty in learning, with each difference in the number of percent in each category. From the results of the PTSDL AUM, the follow-up for the handling is with the guidance of counseling in schools. BK teachers who work with homeroom teachers and all school personnel must strive to provide solutions for handling learning difficulties.

Of the 10 students identified as having learning difficulties as seen based on the results of the AUM PTSDL, the results obtained for the time being were that there were several differences in the problems faced by students according to the PTSDL category, but what was more prominent was the problem category in field D (personal) then Some students also experience a lot of learning difficulties in the T category (learning skills) where one of the statements is classified as a

learning skill category, namely it is difficult to understand certain subjects, then difficulties in arranging words to ask questions, and several other statements.

From every learning process carried out by students, it is expected that the overall completeness is expected. Therefore, the researcher sees that to solve these approaches to learning difficulties, namely through Islamic counseling. According to researchers, Islamic counseling is a pretty good explanation because in overcoming learning difficulties in children, it can be done with several approaches, such as a religious approach, then with several techniques such as external techniques and mental techniques. Because every student who has learning difficulties must have a level of difference in any case. So that Islamic counseling is expected to help the process of solving the problem of student learning difficulties, especially class XI IPA 5 at MAPN 4 Medan seen from the perspective of Islamic counseling.

(Prayitno & Amti, 2007) defines guidance and counseling as the process of giving aid that is done by people who are experts to a or several individuals, both children, adolescents, and adults, so that people are guided to develop the ability of his own and independently with the power of the individual and means that there is and can be developed based on the norms that apply. According to (Musnamar, 2002) Islamic guidance and counseling is a process of assisting individuals to realize their existence as a creature of Allah SWT who should live in harmony with the provisions and instructions of Allah SWT, to achieve happiness in the world and the hereafter.

Some of the results of research trait the importance of guidance and counseling in the development of the activity of learning of students that study Kanga (Kanga, 2015) examined on *Effectiveness Of Guidance And Counseling Services In Enhancing Students' Adjustment To School Physical Environment In Public Boarding Secondary Schools In Kenya*. The results of the study suggest the conclusion that service guidance and counseling have a role in coaching the behavior of students. Service guidance and counseling are used to help students, give first aid to students to behaviors that can interfere with the activity of learning.

(Peter, 2015) research on Access to Guidance and Counseling Services and Its Influence on Students' School Life and Career Choice. The results of the study suggest the conclusion that it is very important the implementation of guidance and counseling in influencing the behavior of the students, including an increase in activity, the discipline of learning, and improvement of the results of learning in school.
